Intended learning outcomes:

- recognize the role and importance of analysing the design information of social enterprise decision-making,
- win a systemic view of social business operations,
- learn the basic tools and methods of analysis,
- learn to use basic tools and techniques of social enterprise business analysis,
- be trained to identify risks to the financial situation and draw up appropriate proposals,
- be trained to explain the results obtained,
- be trained to prepare materials for decision makers,
- develop the ability to participate in the development of relevant information for decision making and thus put oneself in the problems of the social enterprise,
- developing a systematic approach to character traits and professional autonomy.

Metode poučevanja in učenja:

- Predavanja z aktivno udeležbo študentov (razlaga, diskusija, vprašanja, primeri, reševanje problemov);
- Vaje, ki temeljijo na izkušenjskem, sodelovalnem in problemskem učenju (samostojno učenje, diskusija, razlaga, opazovanje, timsko delo, študija primera, metode kritičnega branja in pisanja, evalvacija, samoocenjevanje);
- Individualne in/ali skupinske konzultacije (diskusija, dodatna razlaga, obravnava specifičnih vprašanj);
- Možnost oblikovanje portfolija in samostojen študij (motiviranje, usmerjanje, samoopazovanje, samournavanje, refleksija).

Learning and teaching methods:

- Lectures with active participations by the students (explanation, discussion, questions, cases, problems solving);
- Seminars based on experience based learning, participation in problem learning (independent study, discussion, explanation, observation, team work, case study, methods of critical reading and writing, evaluation, self-evaluation);
- Individual and/or groups consultations (discussion, additional explanation, dealing with specific issues);
- A possibility of portfolio formation and independent study (motivating, guiding, self-observing, self-tuning, reflection).
